22/9/4 APPROVAL OF THE MINUTES OF THE MEETING HELD ON 3RD AUGUST 2022

RESOLVED: the approval of the minutes as a true record.

22/9/5 CHAIRMANS ANNOUNCEMENTS

The Chairman reported on the following:

- He had been to the sites for possible Speed Indicator Device locations and Cllr Duke and himself went through the three quotes for SID's received (See Highways & Footpaths)
- The Council had a report last month in regard to speeding along the A358. It has been reported by the Parish Council but the Police will want to know where is the evidence and not just individual personal perception and they had nothing reported from the public. The Clerk will include in the October newsletter how Parishioners can report on line.
- There has been a Defibrillator recall. The problem being that if the battery was low charge, it
 would read high charge. DPD was supposed to pick up the device but didn't turn up on the
 day they stated but did turn up a few days later. It has all been sorted now and the Clerk has
 purchased a new battery for the device, at a cost of £199, as the five-year battery
 replacement is due October 2022.

22/9/6 LOCAL COUNCIL NETWORKS

Consultation period – 5th September – 17th October 2022

Unfortunately, the consultation did not arrive until the 6th September giving little time for consideration and a reply. The Clerk has sent a paper version of the questions and if Cllrs can send their responses to the Clerk before the October meeting, the Clerk can then collate ready for the October meeting.

It was agreed to defer until the October meeting.

22/9/7 PLANNING

31/22/0014 Demolition of garage and erection of a single storey extension to the side and rear for a garage at 1 Woodland Drive. (amended plans)

Ruishton and Thornfalcon Parish Council objects to this application on the following grounds:

• The proposed structure is significantly bigger than the original garage and will take this new construction to the full boundary with the neighbouring bungalow and therefore will impact this neighbouring property regarding light and proximity.

- The driveway has also been significantly widened with a dropped kerb which will likely cause more parking problems along an already congested area for parking.
- The large extended driveway and dropped kerb again will not be in keeping with other properties in Woodlands Drive, and as such may set a precedent for others to enlarge their driveways in a similar manner in this small cul-de-sac.

22/9/8 HIGHWAY AND FOOTPATHS

Speed Indicator Devices (SIDs)

The Chairman reported that had three guotes as follows:

Solarg £10,000 Westcotec £14,000 Elan City £6750

Recommendation from the Chairman and Cllr Duke is the quote from Elan plus the fact that the Chairman and the Clerk have had favourable reports from other Parish Councils who have purchased from Elan City.

RESOLVED: to purchase three Indicator devices from Elan City at £6750 to be sited at the following locations:

Cheats Road in the vicinity of the old garage.

Middle of Bushy Cross Lane.

The incline of road at Stokes Road

The Council will still need a Chapter 8 trained person to turn the SID's (incoming & outgoing) and replace the batteries.

The Chairman will contact County Highways for to approve the sites and the cost of the poles.

The Clerk will check with our Insurance Company

Community Watch Scheme

After a full discussion, it was stated that vehicles do slow down anyway if they see people in high viz jackets standing at the side of the road as experienced by other councils and this Parish Council.

Plus, the fact that these schemes, although enthusiastic at the start, fold up after a period of time due to a lack of volunteers.

It was agreed to take off the agenda

Any other Highway or Footpath issues

The following problems were reported:

- A 'Give Way' warning sign along Ruishton Lane has faded
- White lining on all the roads in the parish need re-doing
- There has been no further news on the Small Improvement Scheme. The Clerk will contact
 Andrew Nellist for an update especially the situation in trimming the vegetation on the trees
 now that the bird nesting season is over.
- There is still a problem with the pedestrian lights at the Ruishton Lane junction on the A358
 as motorists can be mislead that the light is on green (for pedestrians to cross) when the
 road light is still on red. It was agreed that it had been several months since an
 informal meeting with Andy Coupe. The Clerk will arrange another meeting.
